January 25, 2022

Roll Call

Financial Reports

The following financial reports were reviewed with the Policy Council:

There was a general discussion of various line items. Tonya discussed the Head Start and Early Head Start grant for December 1, 2020, through November 30, 2021, noting that Head Start and Early Head Start were not fully expended and a carryover would be requested after final reports are completed. It was noted Head Start and Early Head Start CARES is fully expended.

Program Goals

Strategic Plan Goals and Objectives for 2018 -2022 was shared. Process for the 2023-2027 Strategic Plan will begin this summer.

EHS Center Based – Year 3: Non-Federal Share Waiver

The non-federal share requirement for the HP Grant is \$385,197.00. Currently, \$7,681.23 is expended. Tonya is requesting approval to submit a waiver.

Tiffany Peterson motioned to approve the request for a waiver. Enrique Cruz-Garcia second. Motion carried.

2020-2021 HS/EHS Annual Report

The Annual Report was reviewed. The report will be provided to all Head Start and Early Head Start families.

Community Needs Assessment

Tonya reviewed the Community Needs Assessment with policy council members. Areas noted:

- The percentage of children eligible for free and reduced school meals is significant in nearly all communities served by the program
- Lack of Mental Health supports and services
- Considerable number of children in foster care and either on an IFSP or IEP
- Lack of quality childcare centers, spots are decreasing in rural areas
- Numbers of live births allows us to estimate number of possible income eligible children

2022-2023 Recruitment Kick-off

Recruitment meeting is scheduled for February 9, 2022.

Vaccine & Mask Mandate – Update

The vaccine and mask mandate are on hold for New Opportunities. Head Start staff and children 2 years and older are required to wear masks in classrooms and centers.

Federal Mileage Rate

Effective January 1, 2022, the Federal Mileage Rate is 58.5 cents per mile.

Eligibility Training

Tonya provided ERSEA (Eligibility, Recruitment, Selection, Enrollment, and Attendance) training.
